



## **Terms and Conditions**

### **Lebanon Petrol Stations & Supermarkets Everyday Spend Offer**

#### **Offer Period**

20<sup>th</sup> September – 20<sup>th</sup> November 2017 (both dates inclusive)

#### **Offer**

Spend \$2,000 on your Card at the participating merchants during the offer period and receive a \$200 statement credit (cashback), based on meeting the eligibility criteria set out below.

#### **Eligibility Criteria**

This offer is open to Cardmembers holding any Basic or Supplementary Cards issued by AMEX (Middle East) B.S.C (c) ("AEME") in UAE, Kuwait, Qatar, Bahrain, Egypt, Lebanon, Oman, Jordan, Morocco, Algeria, Tunisia, Libya and Yemen that are active and current.

Eligible purchases on Supplementary Card(s) will also be considered for the offer.

#### **Purchases and Spend Thresholds**

Eligible purchases mean purchases made at Service Establishments Points of Sale by Eligible Cards, at the following participating merchants:

All combined transactions made at these merchants will contribute to the spend threshold of \$2,000. The statement credit will be capped at \$200 and any transactions made above \$2,000 will not contribute to earning an additional statement credit. The threshold will be applicable on a Basic Cardmember account level where purchases from Supplementary Cards will also be accumulated.

Payment of Fees and Charges, Cash Withdrawal transactions and related fees and cancelled or reversed



transactions and any other payments of outstanding amounts or fees on the eligible Cards will be excluded from this offer.

### **Awarding the Statement Credit (Cashback)**

Eligible Cardmembers will receive the \$200 statement credit to their account, within at most 8 weeks from the end of the offer period.

### **Relationship with Other Offers**

Cardmembers who avail this offer will remain eligible for any other offer or promotion running simultaneously by AEME, unless otherwise specified.

### **General Terms**

Cardmembers' Card Accounts must be shown as active and regular during the offer period and at the time the statement credit is awarded. Any cancelled or deactivated accounts will not be eligible for the offer.

During the offer period all transactions will continue to incur Fees, Charges and applicable Interest rates as per the prevailing Schedule of Fees and Charges.
